### **Overall Test Scoring Takeaways**

- 1. Scores did not vary greatly relative to peer projects
- 2. Equity scoring more fully recognized breadth of existing populations
- 3. Actual scores may be slightly higher due to unscored criteria
- 4. Reduced scores for SOV-focused improvements and unrelated elements
  - Citywide zoning, business improvement districts, auto delay, crashes on unrelated roadways, etc.
- 5. Increased scores for resilience, air quality
