The Boston Region MPO, in coordination with Massachusetts Department of Transportation (MassDOT), and public transit operators, is required to publish a complete list of obligated projects within 90 days after the close of the FFY. The list also includes the approved amount programmed in the TIP, the total amount obligated, and the remaining balance for each project or program. The **FFY 2022 Federal Obligation Report** lists the transportation projects from MassDOT, the Massachusetts Bay Transportation Authority, the MetroWest Regional Transit Authority, and the Cape Ann Transportation Authority within the Boston Region MPO area on which federal funds were expended during FFY 2022 (October 1, 2021– September 30, 2022).
