In 2016 MWRTA served 1500 individuals and in 2017 MWRTA served 1800 individuals, and we anticipate that number will surpass 2000 individuals in 2018. In addition, in order to sustain late-night ADA trips, MWRTA is looking to explore interfaces with outside transportation providers, such as taxis and ride-share programs (Lyft/Uber). For scheduling enhancements, MWRTA will develop visualization software that will allow schedulers to easily identify when software scheduled routes perform inefficiently. The anticipated duration of the project is 1 year. Software developed under this program will be used on an ongoing basis. <b>RTD0007448</b> ; City of Boston - MOBILITY MANAGEMENT	<b>NEW PROJECT</b>	This request is a continuation of a previous request for support for transportation management technologies for the Senior Shuttle. The project focuses on acquiring and implementing a suite of technologies, including both software and hardware that will help the Shuttle to increase efficiency in service delivery. We intend to use the requested funds to purchase the following transportation management technologies: DRT scheduling software, Computer Aided Dispatch/Automatic Vehicle Location (CAD/AVL), a wireless communications system, on-board computers (generally referred to as Mobile-Data Terminals [MDTs]), and an Interactive Voice Response (IVR) system. These technologies will help the Shuttle to achieve responsive dispatching, an efficient deployment of resources, automated scheduling and dispatching, and on-board navigation assistance. The service began in September of 2013 with one community and over the next year expanded to four communities. This effort expanded dispatch access from 2 hours per day to eight hours per day. The expansion of hours provided rider confidence reducing the number of cancelled rides by riders (overbooking). Common dispatch has also allowed the communities to schedule shared trips which has greatly expanded ridership. At this point in time Carlisle, Concord and Sudbury are considering joining the common dispatch in the next fiscal year. A Senior Transportation and Transportation Coordinator administer a transportation network and ridership for elders and adults with disabilities. They serve as the primary contact with clients, manage referrals, provide information assistance, schedule and track transportation services, conduct staff training on transportation and maintain an inventory of cost effective transportation options.
